



Set in one of the most picturesque landscape frames in the world, the Tuscan hills, a natural and unique crossroads of history, art and culture, Villa Rospigliosi, ideally located between Pistoia, Florence and Lucca, a few kilometers from Vinci, the birthplace of Leonardo, is among the historical residences of excellence in Tuscany.

The Villa takes its name from Cardinal Giulio Rospigliosi, Pope Clement IX from 1667 to 1669, who during his brief pontificate commissioned its design to the most renowned architect of the time: Gian Lorenzo Bernini.

However, Pope Clement IX did not have time to live there because he died the same year in which the works began. Nevertheless the project was completed and the Villa was used by the Rospigliosi family as a summer residence until the early twentieth century.

Restored to its former glory by recent restoration works, Villa Rospigliosi hosts the homonymous and prestigious musical competition since 26 vears.

- The competition is open to musicians of any nationality Art. 1
- The aim of the competition is that of promoting musical culture, Art. 2 encourage young people to study music.
- The competition will take place between 4 7 April 2022 at Art. 3 Villa Rospigliosi, Lamporecchio - Pistoia (Tuscany), Italy and Teatro Comunale di Lamporecchio
- The performances will be open to the public and the contestants will Art. 4 have to enter one repertoire, provided they comply with the maximum time-limits:

#### Schumann Award 2022

#### without any age limit / three rounds

- Round One (preliminary round) - Free repertoire. With a duration of between 15 and 20 minutes

- Round Two (semi-final round) - Free repertoire including at least one relevant work, or part of it, by Schumann, Time Limit 30 min - Round Three (final round) - A piano concerto chosen among the following: Mozart: K466-467-488, Beethoven: n.1-3-4-5, Chopin: n. 1 n. 2, Schumann op. 54, Liszt: n. 1 e 2, Ciaikovski: n. 1, Rachmaninoff: concerto op. 18, Scriabin: concerto op. 20. The soloist will be accompanied by Città di Grosseto Orchestra conducted By Valentin Doni, (a maximum of three contestants will be admitted to perform with the orchestra).

without any age limit, one round - Free repertoire. Time Limit 25 minutes Competitors participating in the Rospigliosi Prize can submit pieces to participate in the Edi-Pan and / or Florestano Prize and do not fall within the maximum time limits.

- "Edi-Pan Edizioni" Award: presenting a piece by Teresa Procaccini taken from: "Nove Preludi op. 29, "Sonatina n. 2 op. 46", "American Dream" six pieces for piano op. 220 and the pieces can be found on the publi sher's website www.edipan.com.

- "Florestano Edizioni" Award: presenting a piece by Giorgio Farina taken from the albums "Quadretti sonori", "Daedalus Music" and "Trilogie" ed. Florestano. The pieces are available on the publisher's website www.florestanoedizioni.it
